TERMS OF AGREEMENT

THE ARTIST

- 1. Commits to always uphold high professional standards in executing their mandate.
- 2. Shall at all times respect and protect the brand during the validity of this document.
- **3.** Shall always avail in the meetings (if any) and shall not miss any of the recording not unless of an avoidable circumstance.
- **4.** Shall always inform Tatua media a day prior via mail in case of unavoidable circumstance that He / she cannot avail in the meetings or recording, giving the reasons.
- 5. Shall record/submit in all recordings in the season.

TATUA MEDIA NETWORKS

- 1. Shall always ensure conducive working environment for the artists.
- 2. Shall always ensure equality and integrity in awarding the wining ARTISTS Overall winner, Judges award and any other award that may be decided on by Tatua media networks and its partners or sponsors.
- 3. Shall always attend to **VALID** welfare concerns of the artists at all times.

REUSE

Producer shall have the ultimate right in perpetuity to expose the picture theatrically, on television, the internet, home video and the ancillary rights therein in any and all media whether now known or thereafter discovered throughout the universe, and in the event, producer exercises such rights, and unless provided for in this agreement, Artist shall receive no additional compensation.

TERMINATION

- a) Either party may terminate the performance by giving written notice to the other, if that other party breaches any term of this agreement and, (where the breach is capable of rectification) having been given 5 days' notice requiring it to rectify its breach.
- b) The Event may terminate the performance immediately, without any notice to the Artist if any member of the Artist commits any act of serious misconduct, including (without limitation):
 - i. Any act of fraud or dishonesty;
 - ii. Any act which may injure or endanger any other person;
 - **iii.** Any act which may directly or indirectly damage the reputation of the Event or the Event; or
